### Warm up areas

Lunging is permitted on the entrance end of the sand area up until 45 minutes before the first test is to be ridden for the day. After this time lunging is not permitted in the sand warm up area.

Warm up can be undertaken on the grass area closest to the sand arena gate and in the sand area. There is to be no more than 6 horses in the sand warm up area at any one time.

### Gear check

The gear check will be at the entrance to the sand areas.
